Clarkson University's Global Business Programs is excited to provide the opportunity for students to receive a Global Business Programs Scholarship.

Here are the Program Basics:

What? A limited number of partial scholarships will be awarded to students who complete the attached application and submit a short essay which indicates their desire and reasons for participating in one of the Global Business Programs.

Who? This scholarship is available to freshman, sophomore and junior students who have a desire to enhance their international educational experience and who demonstrate financial need.

Where? Any of the Global Business Programs offered in Spring 2019.

When? The course is scheduled during spring semester 2019. Students selected to participate in a Global Business Program will enroll for a three credit course (UNIV399) for the spring semester. The professor leading the program will schedule class meetings during the spring semester. The completion of this course will be a two-to three-week trip, abroad led by the professor during spring/summer of 2019.
